



## Privacy statement

### Introduction

This website, <https://www.trescoaching.nl> is maintained by Trescoaching (Thérèse van den Oever) in collaboration with Coers Internet Training & Services. This privacy statement explains how Trescoaching handles the processing of personal data of visitors to the website. The privacy statement describes, among other things, which categories of personal data are collected, for what purpose the personal data are used and to which categories of recipients personal data are provided.

### Information about practice Trescoaching

Trescoaching is located in Baexem and registered in the trade register of the 'Kamer van Koophandel' under number 69029091. ### Processing of personal data

Registration for coaching sessions takes place by telephone or via the website. When registering via the website, you will be asked for your name and e-mail address and you can send a personal message. You will receive a reply by e-mail and an appointment will be made. Your name and email address are then known to the mail server of the hosting party Coers Internet trainings & services. Your data will not be used for sending newsletters and will not be shared with third parties for commercial purposes. The notes of the conversations are only recorded on paper. The notes of the conversations will be kept and protected by Therese van den Oever. No digital report is made of the conversations, only your name and address and the data on the invoice, are stored digitally.

### Privacy around conversations

The privacy statement will be explained during the first conversation. The content of the coaching sessions remains between the coach and the coachee and is not shared with third parties unless it could be of use, than explicit permission is requested from the coachee.

### Storage period

Trescoaching does not store the personal data on paper and the digital invoice data for more than 10 years.

## Processing of data by third parties

Only the data on the invoice can be seen by processors and sub-processors on behalf of Trescoaching. The processors and sub-processors act under the responsibility of Trescoaching and are not allowed to carry out their own processing on the personal data. Your personal data will not be provided to other parties, with the exception of the parties as described in this privacy statement. Your personal data will be provided to other parties if we are obliged to do so on the basis of the law or a court decision.

## Your privacy rights

On the basis of the General Data Protection Regulation (hereinafter: "AVG") you have a number of rights. You have the right to request Trescoaching to inspect (article 15 AVG) of and rectification (article 16 AVG) or to erase your personal data (article 17 AVG). You also have the right to request Trescoaching to limit the processing of personal data (Article 18 AVG). Under certain circumstances you also have the right to transfer data (Article 20 of the AVG) and the right of objection (Article 21 of the AVG).
